

## The QOZ Marketplace Now Lists Qualified Opportunity Zones and Opportunity Zone Funds for Investors Seeking to Defer Capital Gains Taxes

Las Vegas, NV, January 2, 2019 -- The Reg.A Funding Group announced today that they have published their QOZ Marketplace website, a resource created to promote both Qualified Opportunity Zones and Opportunity Zone Funds for investors seeking to defer their capital gains taxes. Thanks to this IRS sanctioned program, anyone who has triggered a capital gain by selling an asset like stocks or real estate can receive special tax benefits if they roll that gain into an Opportunity Fund within 180 days.

An Opportunity Zone Fund is a new investment vehicle created as part of the "Tax Cuts and Jobs Act of 2017" to incentivize investment in targeted communities called Qualified Opportunity Zones (QOZ). QOZ's are census tracts designated by state and federal governments targeted for economic development. Opportunity Funds allow investors to defer federal taxes on any recent capital gains until December 31, 2026, reduce that tax payment by up to 15%, and pay as little as zero taxes on potential profits from an Opportunity Fund if the investment is held for 10 years.

Because Qualified Opportunity Zones are so new, many are confused about how they can benefit and participate. The QOZ Marketplace brings together all the <u>news</u>, information and industry players needed to make smart and informed decisions in a unique and easy to understand manner.
